Patrons and staff are expected to follow all posted Rec Cen regulations and all requests by Rec Cen staff. Recreation department management reserves the right to refuse admittance, sales of memberships or day passes, as well as the right to revoke day pass and membership privileges at any time.

<u>Unauthorized entry (fence jumping) and/or fraudulent card use will result in an automatic two-week</u> suspension of Rec Cen privileges. Repeat offense will result in termination of privileges.

Students, Staff, Faculty, Rec Cen Members and Day Pass Users:

- A valid picture ID is required to enter the facility, buy a Day Pass, or purchase a Rec Cen Membership.
- Staff, faculty and guests must sign a waiver of liability to enter the facility or purchase a day pass or membership.
- All minors must present a waiver of liability completed and signed by their own parent or legal guardian.
- Rec Cen members will receive a photo ID card upon joining. The same card will be used for subsequent renewals.
 There is a fee to replace a lost or damaged card.

Rec Cen Policies:

- Smoking (including e-cigarettes), alcohol, drugs, gum, and glass containers are prohibited in all areas of the Rec Cen complex.
- Trespassing, access card fraud, verbal or physical threats or acts of violence will result in loss of Rec Cen privileges.
- Roller-skating and skateboarding within the Rec Cen complex is prohibited.
- Athletic shoes are required in the fitness centers and on all cardio machines at all times: no open-toe shoes, boots, sandals, dress shoes or cleats. Vibram "Five-Fingers" soft shoes are allowed but discouraged in the fitness centers.
- Athletic attire, <u>including a shirt</u>, is required in both fitness centers and on all cardio machines at all times. No denim jeans, jean shorts, pants with metal rivets, belts, or other objects which can tear upholstery.
- Persons with injuries requiring casts or slings must have a physician complete and sign a Rec Cen "Orthopedic Clearance Form" before being allowed to use Rec Cen fitness centers and / or cardio machines.
- All racquetball and squash players must wear protective eye gear. Goggles are available free of charge.
- Bicycles, mopeds and unicycles are not allowed in the Rec Cen and must be parked in racks or designated areas.
- Bicycle shoes or cleats of any sort must be removed at the front desk area before entering the complex.
- Fitness Center shelves are provided for personal gear only. Please do not store valuables in these areas.
- For valuables, day locks may be rented. Personal day locks are allowed but if left overnight will be cut off.
- Lockers, including lock & towel service, may be rented on an annual or quarterly basis.
- The Recreation Center is not liable for lost or stolen items.
- No food or sodas are allowed in the Fitness Centers.
- Only UCSB Recreation instructors may conduct individual or group lessons or personal training sessions.
- Animals, including those on leash, are prohibited. Exception: service animals.
- Photography or filming requires a university permit, obtainable from UCSB Risk Management at 893-2860.
- Individual amplified sound is not permitted.
- Posting flyers or newsletters anywhere in the Rec Cen complex is prohibited without prior permission.
- Special events must be booked three months in advance. Student events require approval by Recreation Department administration and/or Rec Cen Governance Board.
- Children 6 years & older must use their same sex locker room. For assistance, contact a Rec Cen Supervisor.
- Fitness Center etiquette requires wiping down machines & mats after use. Detailed etiquette requirements are posted.
- Visitors touring the facility may not participate in activities and must comply with all Rec Cen policies.
- Rec Cen users are covered by UC and UCSB policies and procedures regarding Sexual Harassment. It is important
